NUMBER OF DELEGATES:

INDIVIDUAL MEMBERS may appoint a delegate to represent each group of up to 10 of them who are present. If an Individual Member is also a member of a Society, she/he cannot be included in the ten appointees, which constitute a voting unit. The breakdown is as follows:

1-10 in person	1 vote
11-25 " "	2 votes
26-50 " "	3 votes

By-Law Number One, Article 3, Section 1 (Delegates) reads as follows:

Each member society shall be entitled to representation by a delegate or delegates at any annual or special meeting of the Council. The total number of delegates from each member society shall be in proportion to the number of members of such society as declared by the duly authorized officers of the society at least ninety days prior to the Annual or Special Meeting of the Council as follows:

(a) Up to one hundred	2 delegates
(b) One hundred and one to one hundred fifty	3
(c) One hundred fifty-one to two hundred	4
(d) Two hundred and one to two hundred fifty	5
(e) Two hundred fifty-one to three hundred	6
(f) Three hundred and one to three hundred fifty	7
(g) Three hundred fifty-one to four hundred	8
(h) Four hundred and one to four hundred fifty	9
(l) Four hundred fifty-one and over	10
